

Impact Grant Application Instructions 2026

WHO IS ANGEL CHARITY?

Angel Charity for Children, Inc. is a nonprofit organization of 250 devoted volunteer members. Our mission is to improve the quality of life for children in Pima County. This is accomplished through an established program of fundraising for the beneficiaries selected annually by the General Membership. We are fortunate that for 43 years, we have positively impacted the lives of over 1.2 million children in our community through the donation of almost \$35 million dollars to 152 projects.

WHAT WE FUND

Angel Charity for Children, Inc. is accepting Impact Grant requests in 2026 for \$100,000 to \$900,000.

Applicants must serve children aged 18 and under in Pima County.

The agency must be a tax-exempt organization as determined by the IRS, having held this status for a minimum of three years.

We fund Impact Grants that directly benefit children in Pima County for:

- a) Purchase of Real Estate and Possible Construction
- b) Construction on Currently Owned Real Estate Property
- c) Retirement of Mortgage
- d) Purchase Equipment/Personal Property/Asset
- e) Program Expenses
- f) Combination of Above

An agency may not apply this year if it was chosen as a beneficiary last year. Private "operating" foundations are eligible to apply, but private foundations are not.

APPLICATION DEADLINE

A Letter of Intent for 2026 Impact Grant is required and due on **November 10, 2025 at 6PM**. A full application cannot be submitted without previously submitting a Letter of Intent through ReviewR.

The full application will be available on **November 20, 2025**. You will have the opportunity to review what you have previously submitted in your Letter of Intent, make updates, and complete the application. Applications with all requested attachments must be submitted through ReviewR by 6:00 pm, **Thursday, January 8, 2026**.

APPLICATION INSTRUCTIONS

- 1. Funding may be requested in more than one category.
- 2. Applications with the requested attachments must be submitted by the due date through the ReviewR portal.
- 3. Make sure that each attachment is clearly titled, including your agency's name in the file name.
- 4. By submitting an application, the agency agrees to enter into Angel Charity's Beneficiary Agreement. The Beneficiary Agreement will govern the specifics of the Angel Charity Impact Grant to the agency.
- 5. By submitting an application, the agency agrees to a first-position forgivable lien for up to ten years. Examples of collateral that may be used to satisfy the terms of the forgivable lien may be any fixed asset or an immovable property such as real estate property, buildings, houses, land, bank deposit, investment account, etc.

The lien will secure the agency's obligation to use the funding from this grant as specified in the application, in compliance with the Beneficiary Agreement.

- 6. If funds provided by Angel Charity are used to pay the costs of construction included in
 - a) Purchase of Real Estate and Possible Construction, or
 - b) Construction on Currently Owned Real Estate Property

The agency will be responsible to complete construction before Angel Charity funds will be provided.

This will require the agency to use its own funds on an interim basis or obtain construction financing for the project. The agency will need to provide a letter of interest from its lender. The Angel Charity Beneficiary Agreement shall not be subject to assignment or pledge in connection with any financing.

- 7. For funds requested in the following categories, funding will be disbursed no earlier than May, 2027 and after the agency has acquired the real estate and/or after the construction is complete.
 - a) Purchase of Real Estate and Possible Construction
 - b) Construction on Currently Owned Real Estate Property
- 8. For funds requested in the following categories, funding will be disbursed no earlier than May, 2027. Program expenses are reimbursed after they are incurred.
 - c) Retirement of Mortgage
 - d) Equipment/Personal Property/Asset
 - e) Program Expenses
- 9. Representatives from each applying agency must be available throughout the entire selection process to provide any additional information needed.

PRESENTATION INSTRUCTIONS FOR SELECTED AGENCIES

- 1. Selected agencies will be required to present to the Angel Charity Selection Committee. The agency will be assigned a liaison team from the Charity Selection Committee to aid in preparing for the presentation(s) and will be available to assist you.
- 2. You will be contacted by your liaisons on or before January 22, 2026. Your liaisons will provide the location, date and time of your initial presentation. Your liaisons will arrange to meet with you prior to your first presentation to the selection committee to review the process, and answer questions. Please let the Charity Selection Chair know if you have not been contacted.
- 3. No more than four people may be present to represent your agency. No one under 18 years of age or any animals except working service animals may be present. An Angel Charity member is not eligible to present to the Charity Selection Committee or the General Membership. Presenters typically include:
 - Executive Director or CEO
 - Chairman/President of the Board of Directors or other Board Member
 - Individual responsible for completing/providing financial info on application
 - One staff member or a parent of a child served by your agency.
- 4. Presentations should include a brief description of services provided, why the agency and services are important to our community, why funds are being requested of Angel Charity for Children, and why help is needed now.
- 5. Handouts are not permitted, including brochures, reports, props, etc.
- 6. PowerPoint presentations are permitted with up to 20 slides, no larger than 100 MB and videos and audio are not allowed within PowerPoint presentations. Please review your presentation with your Angel liaisons. Send your presentation to the Charity Selection Chair via email no later than midnight on **Friday, January 30, 2026**. Bring a flash drive with your presentation on it the day you present "just in case".
- 7. After each agency has presented to the Charity Selection Committee, the committee will choose several Semi-Finalists.
- 8. If chosen as a Semi-Finalist, a brief on-site visit will be made. Committee members will be allowed to ask questions during the visit. Agencies will be notified of the approximate time of the visit by their liaisons.
- 9. After the site visits, the Charity Selection Committee will choose Finalists to make a presentation before the General Membership at Angel Charity's Annual Voting Meeting. The same presentation instructions used in the Charity Selection Committee process apply for the Finalists will be contacted the afternoon of the Voting Meeting with the decision of the membership.
